Representative Matters

Commercial Financing

- Negotiated \$300 million syndicated, secured revolving credit facility for a U.S. public company.
- Represented a cosmetics company in negotiating a \$10 million syndicated revolving credit facility secured by inventory and receivables in Canada and the U.S.
