# Patent Litigation

 Successfully represented the defendant in a multimillion-dollar patent infringement dispute related to employee activity monitoring software. The plaintiffs originally asserted infringement of three patents. Two of the patents were found not infringed on summary judgment. The infringement and validity of the third patent were successfully tried to a jury in Delaware district court, the jury returning a verdict of both non-infringement of the patent and invalidity of several of the asserted claims.



- Helped a public, construction-product company in a challenging patent infringement dispute with a direct competitor that spanned six years and encompassed multiple federal court cases in the U.S. and Canada, as well as proceedings before the Patent Trial and Appeal Board.
- Secured a favorable settlement for a patent owner in an infringement action in the Middle District of Florida.
- Acted as local counsel in high stakes patent litigation involving consumer electronics and smartphones in the Northern District of California.

#### Trademark Litigation

- Represented a Napa Valley wine producer in a trademark and trade dress infringement case against a photographer and a Sonoma wine producer attempting to introduce wine products using the image and likeness of Marilyn Monroe in violation of the client's trade dress rights in such images. We successfully obtained preliminary injunctive relief on behalf of the client in a case-of-first-impression decision by the federal district court holding that images of celebrities may constitute valid and protectable trademarks and trade dress.
- Represented a construction company in a trade secrets
  misappropriation and patent infringement case concerning inventions
  related to the disposal of concrete washout waste. We obtained
  summary judgment in favor of the client, defeating the plaintiff's
  claims.
- Successfully defended manufacturers of high-end denim jeans against claims of trademark infringement asserted by a well-known denim jeans manufacturer.
- Successfully defended a well-known, San Francisco-based bakery against claims of trademark and trade dress infringement and breach of contract by one of its investors concerning the bakery's naming and ownership rights. We successfully negotiated a settlement that allowed the client's business to continue undisturbed.
- Represented a small, Bay Area-based business in an action in the Northern District of California between two competing manufacturers of signage products involving utility patents, design patents and trade dress. We achieved a preliminary injunction based on trade dress infringement that led to a favorable settlement of the entire matter.



 Prosecuted and defended a variety of trademark opposition and cancellation proceedings in front of the USPTO's Trademark Trial and Appeal Board for clients that included a winemaker, a local restaurant chain, a developer of a popular smartphone app, a medical device manufacturer, a large computer network company, and a small foreign manufacturer of gluten-free food products.

# Trade Secret and Unfair Competition Litigation

of falsely advertising the contents of its products.
