SHARTSIS FRIESE FUNDS FELLOWSHIP AT BAY AREA LEGAL AID TO HELP END DOMESTIC VIOLENCE

Three-year fellowship will help hundreds of San Mateo County residents escape domestic violence.

San Mateo, CA – Survivors of domestic violence will have greater access to legal services in San Mateo County thanks to the Shartsis Friese Public Interest Fellowship.

Shartsis Friese LLP is pleased and honored to announce that the firm has selected Bay Area Legal Aid as the recipient organization for the second three-year Shartsis Friese Public Interest Fellowship. Established by the firm in 2004, the Shartsis Friese Public Interest Fellowship was founded to help serve those members of the Bay Area community who cannot afford needed legal services. The Fellowship funds a staff attorney position at a local legal services organization each year for a three-year term. Varner received her undergraduate degree from the University of California, Santa Cruz in women's studies and communication. In 2007, she received her J.D. from New College of California, School of Law. Varner is fluent in both English and Spanish and has worked in immigration, family and housing law for over eight years.

Varner will work with two BayLegal family law attorneys in San Mateo County providing legal representation to domestic violence survivors. Varner will take a holistic approach to helping families escape domestic violence by providing a full range of legal services designed to stabilize each family; including assistance with restraining orders, divorces, access to affordable housing, and related immigration issues.

Varner served as a legal intern in 2005 at BayLegal's San Mateo County office. During that time she assisted domestic violence survivors with restraining order applications as well as with immigration matters under the Violence Against Women Act.
