- Sears, in which he represented three landlords holding nine separate properties
- WeWork, in which he represented multiple landlords and resolved a contentious dispute regarding failure to pay administrative rent.

In addition, Ivo has served as a court-approved attorney for receivers, referees and bankruptcy trustees, helping them analyze claims, resolve disputes and win authorization to sell distressed assets.
